Dear Sir,

I, B. Subramanian, Practicing Company Secretary, Flat No: 1, Prithvi Apartments, No. 7/4, Seethanagar Second Street, Chennai – 600 034, have been appointed as Scrutiniser by the Board of Directors of M/s. Polyspin Exports Limited, at its meeting held on 3<sup>rd</sup> February, 2020 for conducting Postal Ballot / E-voting process and I have given my consent to act as Scrutinizer vide letter dated 3<sup>rd</sup> February, 2020 for passing the following Special Resolutions through Postal Ballot:

1. Adoption of New Articles of Association.
2. Appointment of Sri. S.R. Subramanian for continuation as a Non-Executive Director.

I hereby submit my Report as under:

- a. There were 3,261 Members of the Company on cut-off date i.e. 8<sup>th</sup> February 2020. Out of 3,261 Members, 1,101 Members had registered their e-mail id with M/s. Integrated Registry Management Service Private Limited (RTA). Postal Ballot Notices along with Postal Ballot Forms were sent to 1,101 Members through e mail. To the remaining 2,160 members Postal Ballot Notices with enclosures along with Postal Ballot forms and Business Reply Envelopes were sent through Registered Speed Post on 15<sup>th</sup> February 2020.
- b. The Company had issued Public Notices about the despatch of Postal Ballot Forms / Notices in Business Line (English Newspaper) and in Dinamalar (Regional language Newspaper) on Saturday, February 15, 2020.
- c. The Company has availed the services of National Securities Depositories Limited (NSDL) to provide e-voting facilities to the Members of the Company.
- d. The remote-voting commenced from 9:30 a.m. (IST) on Monday 17<sup>th</sup> February, 2020 and ended at 5:00 p.m. (IST) on Tuesday 17<sup>th</sup> March, 2020.

- e. I have monitored the process of electronic voting through the Scrutinizer's secured link provided by NSDL on the designated website [www.evoting.nsdl.com](http://www.evoting.nsdl.com).
- f. In the Business reply envelope, BR Permit No. TN/CH(C)/BRP/1046 Thyagaraya Nagar P.O. of M/s.Integrated Registry Management Service Private Limited, Chennai, was mentioned and hence all envelopes were sent at that address and collected by Integrated Registry Management Service Private Limited. I had collected all the envelopes from Integrated Registry Management Service Private Limited on 17<sup>th</sup> March, 2020. All the envelopes were opened by me and the same were serially numbered.
- g. The e-voting module was unblocked at 10:15 A.M. on 18<sup>th</sup> March, 2020 in the presence of two witnesses, Mr.K.Samidurai and Mr.G. Raja Annamalai who are not in the employment of M/s.Polyspin Exports Limited. They have signed below in confirmation of the votes being unblocked in their presence and the e-voting results/list was downloaded from the NSDL website.

- h. All postal ballot forms received from Integrated Registry Management Service Private Limited on 17<sup>th</sup> March, 2020 and e-votes casted up to 5:00 p. m. on 17<sup>th</sup> March, 2020 the last date and time fixed by the Company for receipt of the votes/ forms were considered for my Scrutiny.
- i. I received 73 (Seventy three only) Postal Ballot Forms from Integrated Registry Management Service Private Limited. All the 73 (Seventy three only) Postal Ballot Forms were opened and serially numbered. I verified the signatures and other details from the data available with M/s. Integrated Registry Management Service Private Limited and found that 72 (Seventy two only) out of the 73 (Seventy three only) Postal Ballot Forms were valid. One Postal Ballot was rejected due to the shareholder had casted E-Voting electronically as well as Postal Ballot.
- j. Therefore, after verification, I have considered 72 (Seventy two only) Postal Ballot Forms as valid.
